

# STUDENT DRUGS AND DRUG EDUCATION POLICY

#### Introduction

Penola Catholic College, enlightened by the Gospel Values of Faith, Love, Hope and Compassion, strives to provide a holistic education, which meets the needs and gifts of each student.

Raising critical awareness by educating about drugs and their physical, emotional and psychological effects are an essential aspect of the holistic education provided at the College.

In addition, Penola Catholic College acknowledges the importance of prevention practices in regards to the use of both legal and illegal drugs. Therefore there is an emphasis on strategies and structures, which promote and encourage improved personal health through resilience, self-esteem and a well-balanced lifestyle.

#### Definition

Drugs are substances that may alter mental and / or physical processes such as mood, cognition, thinking, behaviour or physical performance.

Drugs may include legal substances such as alcohol, tobacco or pharmaceuticals (prescribed and non prescribed). Drugs may also be illegal substances. The production, sale, possession or use of illegal drugs is prohibited.

### **College Position Statement**

In the light of the above definition, the College does not permit the use, possession or distribution of tobacco, alcohol, chemicals, other illicit drugs or drug paraphernalia on College premises.

In compliance with our legal responsibilities, any student who uses, is in possession of, or distributes any drug deemed to be illegal by the State, will be dealt with according to mandated processes and this will result in a referral to government authorities.

 Actively discourage student involvement in the use, possession and/or distribution of tobacco, alcohol and any illicit drugs.
